## DAYCARE, BOARDING & PET CARE AGREEMENT

1. You understand and agree that by allowing your dog/cat service with Canine Social Club, (hereinafter referred to as "CSC"), that CSC has relied on your representation that your dog/cat is in good health and that your dog/cat has not harmed or shown any aggressive/threatening behavior toward any person or any other dog/cat.
2. You must provide proof of vaccinations of your pet. Dogs must show proof of current rabies, parvo and bordetella. Cats must show proof of current rabies and distemper.
3. You understand and agree that CSC and their staff are not liable for any problems that develop, provided reasonable care and precautions are followed, and you hereby release CSC and hold them harmless for any and all liability arising from your dog/cat's attendance at CSC. You agree to assume all liabilities and responsibilities, financial or otherwise, for the behavior and health of your dog/cat.
4. You understand, even with all precautions taken by CSC, that CSC cannot assume responsibility for any nicks or scratches that may occur while your dog/cat is in groups. Furthermore, CSC may or may not notify you immediately if your dog/cat sustains any minor nicks or scratches.
5. You understand that dogs/cats may occasionally develop problems from environmental or dietary changes. Some signs may include vomiting, diarrhea, coughing, sneezing, scratching or biting the skin. CSC will take great care and precautions that these problems won't occur; however, you are aware and understand these conditions can develop and that CSC is not financially responsible for these inherent conditions if they do occur.
6. You understand that CSC is not responsible for any personal property left with CSC, including but not limited to beds, blankets, clothing, bowls, food, collars, leashes or toys.
7. You agree to pay \$3 per meal for dogs and \$2 per meal for cats if you did not provide sufficient food for your pet's boarding with CSC.
8. You agree to notify CSC if there are any changes of plans in your pet's check-out time and date. You understand that if you don't notify CSC of a change of departure time within a period of 24 hours after your dog's scheduled release time; CSC, at its own discretion, will consider your pet abandoned according to the animal abandonment laws in the State of Illinois. You agree to be responsible for any fees accrued and any other fees or legal services incurred as a result of the abandonment.

9. You understand and agree to the following check-in and check-out times along with any additional fees accrued due to late pick-up:

**DAYCARE CHECK-IN:** M-F 6:30AM to 9:30AM  
Sat. 8:00AM TO 10:00AM

**DAYCARE CHECK-OUT:** M-F 3:30PM to 7:00PM\*  
Sat. 3:00PM to 5:00PM \*  
Not open for daycare on Sundays and holidays

**\* LATE CHARGES:**

After 7:00PM (5:00PM on Saturdays) we will have to apply a \$10 surcharge. After 7:30PM (5:30PM on Saturdays), your pet will be boarded overnight at the overnight boarding charges.

**BOARDING CHECK-IN:** M-F 6:30AM to 7:00PM  
Sat. 8:00AM to 5:00PM  
Sun. 10:00AM to 2:00PM

**BOARDING CHECK-OUT:** By 12:00PM\*\*

\*\* LATE CHARGES: If you will not be able to pick up your pet by noon, you will be charge one day of daycare at \$16 for the last day. Please pick up your pet by the end of the day during regular business hours. Refer to check-out times for daycare. Note that there is no daycare on Sundays and Holidays and you will be charged an additional day at the boarding rate in such case.

**SUNDAY SOCIAL CHECK-IN/OUT:** Sun. 10:00AM to 2:00PM\*\*\*

\*\*\* The owner must be present and supervise his/her own dog(s) at all times. Maximum number of dogs per owner at any time is two.

10. You agree and understand that a 50% deposit is required for all pets boarded with CSC, refundable only if canceled 24 hours prior to service for non-holiday dates and 72 hours prior to service for holidays. Holidays are New Years Eve & Day, Easter Weekend (Fri.-Sun.), Memorial Day Weekend (Sat.-Mon.), Independence Day Weekend (varies each year depending on the day of the week the holiday falls on), Labor Day Weekend (Sat.-Mon.), Thanksgiving Weekend (Thurs.-Sun.) & Christmas Eve & Day. The remaining balance is due at pick-up.
11. You authorize CSC to charge your credit card for all fees and charges you or your dog may incur, prior to taking custody of your dog. You understand that CSC may decline to provide services to you or your dog if your credit card has been declined.
12. You agree that if you pay by check and your check is not honored when presented for payment, CSC may charge the full amount due plus a returned check fee of \$25 to your credit card.
